Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized. Professional handlers are not permitted to exhibit in this class. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise.

Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this 4 & Under 6 Months Puppy in Competition.

Amateur-Owner-Handler Class (effective as of 1/1/2009)

Chapter 3, Section 7 - The Amateur-Owner-Handler Class shall be for dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13).

***NR1.08100.15000*. Veteran Classes** - Class for dogs & class for bitches 7 years & over. Dogs may be neutered & bitches may be spayed and can compete in Best of Breed Competition.

00900. BEST OF BREED COMPETITION

Non-Regular Classes Involving Multiple Dog Entries

***NR2.09100*. Stud Dog Class** - Will be for Stud Dogs and at least two but no more than four of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be owner of Get. Get only to be judged based on the merits of the Get. Get MUST be entered in one of the Regular Classes, Best of Breed Competition or some other Non-Regular Class. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the Standard for its breed. **Entry fee is \$22.00 as a first entry or as an additional entry.**

***NR2.09200*. Brood Bitch Class** - The same as Stud Dog except substitute Brood Bitch for Stud Dog & Produce for Get.

***NR2.09300*. Brace Class - Two dogs of the same breed, must have at least one common owner & presented by a maximum of two handlers. - Entry Fee is \$22.00 per unit as a first and as an additional entry.** The dogs comprising a Brace MUST be named at time of entry. If a dog that is to be part of a Brace is not entered in another class, it must be entered for "Brace Class Only." In making entries for "Brace Class Only," full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes, "Brace Class." If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated, "Brace No. 1," Brace No. 2," etc.

***NR2.26400*. Generations** - For three dogs, regardless of sex, of three successive generations (grandparent, parent, offspring). Entry is made for each dog (three separate entry forms) and there can be no substitutions of dogs. **\$21.00 entry fee is required for the Unit of three dogs (\$7.00 per dog).** At least one of the three dogs in the unit must be entered in a regular conformation class. Individual dogs may be entered in only one Generations Class unit. Each dog has a separate handler. Champions of Record and altered dogs may be entered.

As the judge's decision in the Non-Regular Multiple Dog Entry Classes are based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed by virtue of having won these classes.

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
