Malinois Preferred Entry

These All-Breed trials are being run similar to an Option 2 Obedience trial. **ALL NON-MALINOIS** entries will be wait-listed until closing. Exhibitors entering a breed other than a Malinois will be notified as soon as possible after the closing date regarding the status of their entry.

Notice to Exhibitors

Entries will open at 8:00 AM on February 1, 2017 CDT at the Trial Secretary's address. Entries received before that time will be returned. Hand-delivered entries will be accepted. Entries sent via expedited mail **must have signature waived**. Make checks or money orders payable to the American Belgian Malinois Club (ABMC). All fees are payable in U.S. funds. Please type or print all information required on entry form. Entry fee per trial per dog per class \$45.00 (sheep)/\$35.00 (ducks). Exhibition only entries will be accepted, with the same breed preference, entry fee and closing time and date as regular entries. Entries close at 5:00 PM CDT, April 7, 2017 at the Trial Secretary's address, after which time entries cannot be accepted, canceled or substituted except as provided in Chapter 1, Section 13 of the AKC Herding Regulations. When numerical limits are exceeded, additional entries will be placed on an alternates' list.

Drawing for running order will be held at the Trial Secretary's home on April 7, 2017 at 5:00 PM CDT. There shall be no refund of entry fees for dogs that are absent, retired, removed, excused or disqualified or if because of riots, civil disturbances, or other acts beyond the control of the Club it is impossible to open or compete in the Trial. If a dog is absent and is replaced by an alternate, then the entry fee shall be refunded. Entrants on the alternates' list must check in with the Trial Secretary on the Trial grounds no later than thirty(30) minutes before the commencement of their class. Alternates that do not have the opportunity to run shall have the entry fee refunded. A separate entry must be made for each class.

Requests to move-up must be given to the Trial Secretary at least thirty (30) minutes prior to the start of the event.

Bitches in season will be permitted to run in catalog order in Trial classes but will be placed at the end of the running order in Test classes.

Returned checks do not constitute a valid entry fee. A \$25.00 collection fee will be added to each returned check.

No refunds will be made for duplicated entries or errors on entry blanks. Owners are responsible for errors in making out entry forms and no entry fee will be refunded in the event of such.

The American Belgian Malinois Club may decline any entries and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim against the American Belgian Malinois Club or any official thereof.

Exhibitors and spectators are expected to keep the entire area clean. Please pick up after your dogs on the trial grounds, including the horse pasture. Anyone witnessed not picking up after their dogs will be excused from the trial, with no entry fees refunded.

The initial handlers' meeting will be held at 8:00 AM with judging to follow. Subsequent handlers' meetings will be held before each class.

All dogs must be held on leash or otherwise restricted except when competing. Under no circumstances will dogs be allowed to disturb the resting stock or interfere outside the arena with another dog's performance in the arena. See Chapter 1, Section 20 of the AKC Herding Regulations.

The American Belgian Malinois Club, its officers and representatives, the Trial Chair, Secretary, Committee and the owner of the Trial site assume no responsibility for loss, damage, or injury sustained by spectators, exhibitors' property and their dogs and further assume no responsibility for injury to children. Owners or handlers entering a dog in the Test or Trial do so at their own risk and also agree to abide by the Rules of The American Kennel Club and the AKC Herding Regulations, amended to September 1, 2006.


Hotels Which Allow Dogs
