#### OBEDIENCE / RALLY REFUNDS & TRANSFERS

**Bitches in Season:** Females in season are not permitted to compete. If a female is withdrawn from competition because it came into season, and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, a full refund will be due the exhibitor.

**Transfers (formerly called move-ups):** After a dog earns a title, it may be transferred to another class in a future trial, even though the closing date for the trial has passed. A transfer (i.e., from an obedience class to an obedience class or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible and the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Movement between an "A" and "B" class at the same level is not considered a transfer – refer to Chapter 1, Section 16b.

**From South:**  
 I-39 North to Hwy 10. Hwy 10 east to Amber Ave. Left on Amber Ave. Hotel on right.

**From West:**  
 Hwy 10 East to Stevens Point. Turn Left on Amber Ave. Hotel on right.

**From North, South and West:** From I-39 in Stevens Point, take Hwy 10 East (towards Waupaca) to Lake Road/Amherst Junction exit. Turn right onto Lake Road. Cross railroad tracks, bear left and continue on Lake Road after first stop sign (Lake Emily will be on your right). Turn left at second stop sign onto Lake Emily Road. Camp Bandy is on the left (approximately 5 blocks).

**From East:** Hwy 10 West to Amherst (approximately 10 miles from Waupaca) to the County B WEST exit. Turn right onto County B. Almost immediately, turn left onto County Road Q. Approximately 1 mile down, road makes a 90 degree turn to the left and becomes Main Street. Stay on Main Street (Q will turn to the right). Camp Bandy is on the right just out of town (approximately 3 blocks).

The dog with the highest combined total score for all venues will be awarded Most Versatile Belgian Malinois. Reserve Most Versatile Malinois will be awarded to the second place finisher. The MVBMA Chair will track the results based on the Show / Trial Secretary information and points for each dog entered will be posted daily. The Award will be presented after the Herding Trial on Saturday, May 13 (morning trial). The winner of the award need not be present to win.
