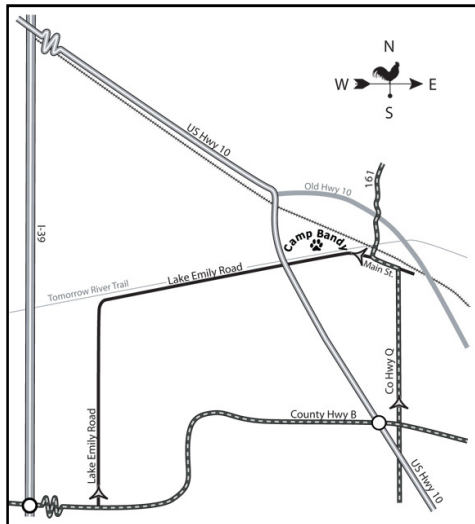

Directions



From North, South and West: Take I-39 to Hwy 10 East (toward Waupaca). Exit on County Hwy B west turn left (east) on Hwy B. From Hwy B, turn left (north) on County Road Q. Go approximately 1 mile and go straight when County Hwy Q turns right. Camp Bandy is approximately 4 blocks on the right.

From East: Take Hwy 10 West (toward Stevens Point). Exit on County Hwy B west turn left (east) on Hwy B. From Hwy B, turn left (north) on County Road Q. Go approximately 1 mile and go straight when County Hwy Q turns right.

Overnight RV Parking is available at Camp Bandy.
