### **SITE INFORMATION**

The test site is on state-owned property; there is a daily admission fee of \$10 (non-resident) and \$7 (resident) to be on the site. Permits can be purchased at the ranger station near the entrance to the park or ahead of time at most state parks and DNR offices. Please help us maintain access to this park for our tests by behaving as responsible dog fanciers, including cleaning up after your dog and respecting other park visitors. Dogs must be on leash at all times.

### **DRAWING FOR TRACK ORDER**

The draw for TD tracks will be held at 8:00 AM and 10:00 AM for TDX tracks, Wednesday, May 10, 2017 at the shelter building. **From park entrance, continue straight to end of the road, turn left and go to first parking lot on left.** The test will begin as soon as practical after the draw. Bitches in season will be permitted to run and will be assigned to the last track.

### **LIMITATIONS ON ENTRIES**

Bitches in season may participate provided that the Test Secretary and Judges are notified that a bitch in season is present prior to the drawing for tracks. The last track shall be reserved for the bitch in season. If there is more than one bitch in season, a second draw for these bitches will be held.

No video taping of this event will be allowed without prior permission of the Test Secretary and the judges.

### **GENERAL TRACKING AND CAUTIONARY DISCLAIMERS:**

No dogs are to be allowed to be "off lead" – due to the changing nature of the fields being used by clubs for tracking tests and the increased population at these sites by the general public, dogs shall be "on lead" at all times on any area of the tracking site. Cancellation of Event may occur due to extreme hazardous weather conditions as determined by the Tracking Committee and Judges.

**DIRECTIONS TO THE TEST SITE**

From the North or South: I39 to Hwy 54. Hwy 54 East towards Waupaca approx. 16 miles. Watch for brown state park signs. Turn Right on Hartman Creek Road. Go South on Hartman Creek Road approx 2 miles. (It will take you straight into the park.) From park entrance, continue straight to end of the road, turn left and go to first parking lot on left.

From the West: Hwy 10 West to I39. South on I39 to Hwy 54 approx 6 miles, then follow directions above.

From the East: Hwy 10 to Waupaca. Go West on Hwy 54, approx 5 miles. Watch for brown state park signs. Turn Left on Hartman Creek Road. Go South on Hartman Creek Road approx 2 miles. (It will take you straight into the park.) From park entrance, continue straight to end of the road, turn left and go to first parking lot on left.
