**Test Locations:** All tests take place near Weldon Spring Hts (mailing address St Charles), MO, west-northwest of St Louis, MO. The sites are close to each other. **TD:** Weldon Spring Conservation Area; **TDX:** August A Busch Memorial Conservation Area; **VST:** University of Missouri Research Technology Park

**Number of Tracks:** The TD Test is limited to 6 tracks. The combined TDX/VST test is limited to 3 tracks each, with the numbers of TDX and VST tracks adjusted based on entries received, in accordance with Ch. 1, Sec. 17a and 19.

**Entries close:** at 6:00 pm, Wednesday, March 14, 2018. Drawing for entries and alternates will occur at 7:00 pm at the home of the secretary, 10325 Denton Creek Dr., Fenton, MI 48430. All interested persons may attend. Exhibitors will receive an email with the results of the draw within 48 hours, or may call 810-208-0520 after 8:00 pm, March 14, 2018 for the results. The drawing of entries will be executed in accordance with Ch. 1, Sec. 17, 17a & 17b of the AKC Tracking Regulations.

**Test Headquarters(HQ):** Stable parking area at August A. Busch Memorial Conservation Area, 2360 Hwy D, St. Charles, MO.

**Test hours:** are 6:45 am to 7:00 pm April 8, 2018. Missouri is in the Central Time Zone. On Sunday, April 8, 2018, all dogs entered in the **TD test** are to be available at Test HQ at 7:30 a.m.. The draw for running order will take place at 7:45 am. Judging will begin as soon after the draw as the first track is ready.

All dogs entered in the **VST & TDX tests** are to be available at Test HQ at 9:15 am. The draw for running order for BOTH tests (VST first) will take place at 9:30 am. Judging will begin as soon after the draw as the first track is ready (VST tracks first).

**ELIGIBILITY:** Open to all breeds, with preference given to Belgian Sheepdogs(BSDs) in accordance with Chapter 1, Section 17b of the AKC Tracking Regulations. Draw priority will be as follows: (1) BSDs not already having the title for the test entered; (2) BSDs already having the title for the test entered; (3) Other breeds not already having the title for the test entered; (4) Other breeds already having the title for the test entered. // Bitches in season may participate in this test in accordance with Ch. 2, Sec. 8 of the AKC Tracking Regulations.

**TRACKING CERTIFICATION:** Entries in the TD Test must be accompanied by an original written statement, dated within 12 months prior to the TD test, signed by a person who has been approved by the American Kennel Club to judge Tracking Tests, certifying that the dog is considered by him/her to be ready for such a test.

**SEVERE WEATHER:** The club may cancel the event in extreme weather conditions.

**MANAGEMENT OF DOGS AT TEST:** Dogs must be leashed or crated at all times.

**YOUR DOG'S HEALTH:** Exhibitors should follow their veterinarian's recommendations to assure that their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**ENTRY FEES (in U.S. Funds): TD: \$75. VST / TDX- \$125.00.**

This includes AKC fees. An AKC Event Service Fee of \$3.00 and an AKC Recording Fee of \$0.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. This fee is to be collected by the trial-giving club and paid to the American Kennel Club, per American Kennel Club Rules, Ch. 11, Sec. 2. Entries not on an official entry form and photocopies of entry forms without Agreement and Rules on the reverse side of the official AKC entry form are NOT ACCEPTABLE. Entries will not be accepted without fees or signature. No entries requiring a signature for delivery will be accepted.

Send entries to the Test Secretary, Carilee Moran, 10325 Denton Creek Dr., Fenton, MI 48430. Entries close on Wednesday, March 14, 2018 at 6:00 PM. Make checks payable to "BSCA". There will be a \$25.00 charge for any returned check.

**ENTRIES** will be acknowledged after the closing date with a judging program. Should the exhibitor not receive such acknowledgment within a reasonable time, please notify the **Test Secretary: Carilee Moran** Ph (810)208-0520 email: [colemich@sbcglobal.net](mailto:colemich@sbcglobal.net)

**REFUNDS** of entry fees for alternates who don't participate in the test will be sent within one week of the completion of the test. Entry fees for dogs which pass an AKC approved test after the closing date of this test will be refunded if they withdraw from this test provided there is an alternate to replace the entry and the Test Secretary is notified **in writing** not less than 3 days before the test date. Any cancellation of entries must be made in writing and received prior to the closing date.

**TROPHIES:** Each dog passing a test will receive a rosette and a breed figure mailbox topper with a running Belgian silhouette. The Belgian Sheepdog Club of America, Inc.(BSCA) offers trophies through the generosity of donors to the trophy fund. All donor names will be listed in the specialty catalog. All ribbons, awards and trophies, if not awarded in the ring, must be picked up by the exhibitor. No trophies will be mailed. Rosettes are offered for all awards and placements by BSCA, Inc. Trophies of greater or equal value may be substituted at the discretion of the Trial or Trophy Chair.

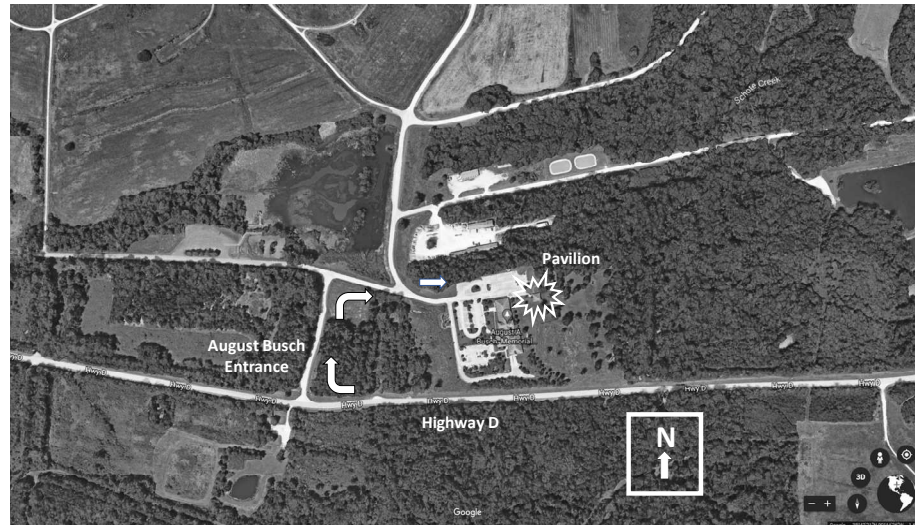

## INSTRUCTIONS

(Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in., but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

(Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
