If a dog is entered in both a test level and a trial level at a single event and qualifies in the trial level, it may run in the test level(s) at the handler's option, but the entry fee shall not be refunded if it is scratched from the test level(s). If a dog qualifies in a test level and attains the second leg toward a test title, a test certificate and title will be issued provided the dog is otherwise eligible, but the dog is no longer eligible for entry in a test level as the result of qualifying in the trial level. A dog may enter a class (level-course-stock) only once per event.
