#### A NOTE FROM THE BOARD:

The 2025 ABMC National Specialty is in the books. Co-Chairs Tiffany Holley and Paige Johnson would like to extend their heartfelt gratitude to the ABMC membership and volunteers for attending this event and helping to make it spectacular.

Suzanne Belger, ABMC Treasurer, would like to share with the membership that the audits required in the Bylaws have been completed. UHY has three main concerns: 1) that bank statements be reconciled as soon as they are received; 2) that ALL payments made have a COMPLETED and SIGNED check request form with LEGIBLE receipt(s) or invoices; and 3) receipts be provided for ALL cash received by ABMC. Suzanne has addressed the concerns set forth by UHY: 1) bank statements will be reconciled by the 5th of the month it is received; 2) NO payments will be made for ANY REASON without a COMPLETED AND SIGNED check request form AND legible supporting documentation (invoice or receipt(s)); 3) ABMC is unable to provide receipts for all cash received, this will be noted for future audits. The Board also discussed that, due to the expense of a professional audit, a professional audit will be conducted in the even number years and an ABMC Member (Non-Board Member) audit will be conducted every off number year.
