A NOTE FROM THE BOARD:

This month's ABMC Board meeting was short yet productive. First, the Board approved four separate event applications, two of which are for multiple date events. One goal of the current Board was to increase ABMC sponsored events being chaired by ABMC members. We are very excited that the membership has reacted positively this and we are seeing more and more Supported Entry shows and Regional Specialties. These events will be published in the Belgian Beat once they are approved by AKC.

Next, communication is proving to be an issue with the AKC Canine Health Fund donation. Rest assured that ABMC President Paige Johnson is working hard to get this donation made and should have another meeting set up with AKC shortly.

Finally, as many of you now, AKC approved herding venues are getting more and more sparse. Sadly, there was no National Specialty Herding Trial for 2025 due to the damage at Purina Farms. The Board has discussed two separate options: 1) having a National Specialty Herding Trial Separate from the National Specialty (preferable before the National Specialty) at a different location than the National Specialty; and 2) holding the National Specialty at the same, somewhat central location each year that provides a location for all National Specialty Venues.
