Reserve Winners

Chapter 16 Section 1 of the "Rules Applying to Dog Shows" provides:

At a specialty show the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five-point major, in the region in which the event is held. No major for Reserve Winners shall be given based upon an award of Best of Winners.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused, or ordered from the ring by the judge, or from which all awards are withheld, shall not be included.

AKC National Owner-Handled Series

(Remember to check the box near the bottom of the entry form)

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

**A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior

Showmanship (meet age & amateur status requirements) may participate in NOHS.

SWEEPSTAKES CLASSES (ALL Classes Divided by sex)

The Sweepstakes shall be open to all Belgian Malinois eligible whose age will be no less than six months and no greater than eighteen months on the day of judging. Champions of record are eligible, provided they meet the age requirements.

Puppies entered in Sweepstakes must also be entered in regular classes.

Puppy Dogs or Bitches, 6 to 9, 9 months and under 12, 12 to 18 months

VETERANS SWEEPSTAKES CLASSES

Veteran Sweepstakes is open to all Belgian Malinois 7 years of age and older as of the day of the show. Enter Veteran Sweepstakes as an additional class. Dogs in Veteran Sweepstakes do not need to be entered in a regular class at this show. Open to Champions, neutered dogs, and spaved bitches. if they are within the age limits.

Veteran Dogs or Bitches, 7 to 10 years, 10 to 12 years, 12 years and older

WORKING SWEEPSTAKES CLASSES

Working sweepstakes honors Belgian Malinois that compete in performance, companion and working events. To Qualify to enter Working Sweepstakes at an ABMC Specialty Show, the dog must have earned, at a minimum, an AKC Novice level title in at least one of the following venues: Obedience (CD), Rally (RN), Tracking (TD/TDU), Herding (HSAC HSAD, HSAS, HSBC, HSBD HSBS, HSCC, HSCD, HSCS), Agility (NA, NAJ, NAP, NPJ, NF NFP) and/or Scent Work (SCN, SIN, SEN, SBN, SHDN). These are the same venues as for the Most Versatile Malinois Award.

Working sweepstakes entrants need not be entered in any regular conformation class. Champions of record may compete but a championship is not required. Spayed or neutered bitches are eligible to compete.

AKC CODE OF SPORTSMANSHIP

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
